Your Donations Hard At Work...



\$159,000 ~ In 2006 a new Ultrasound Machine was purchased capable of providing images in color and greater detail. The Ultrasound can quickly scan for a large array of medical conditions, including taking a 3-D look at unborn infants and the heart's current condition.



\$86,000 ~ In 2007 a new GE Proteus X-Ray machine was purchased to enhance the imaging services at KVCH. The X-ray allows patients to be transferred with ease and also features new technology that accommodates larger patients and those patients in wheel chairs.



\$220,000 ~ In 2008 the Foundation funded the remodel of the Medical Surgical Unit at KVCH and purchased three new defibrillators for KVCH and the Cle Elum Medical Center. The remodel will convert the rooms from semi-private to all private patient rooms.



\$38,500 ~ In 2009 the Magical Evening Gala raised funds to purchase two pediatric monitors for our smallest patients. These new monitors accurately record vital signs of infant and pediatric patients.
